

Selectmen's Meeting Minutes  
March 26, 2012

Present: Chairmen Smith; Selectmen Schill, Selectmen Ebbighausen, Selectmen Darcy, Selectmen Rideout ; TA Collins.

6:00 p.m. Chairmen Smith called meeting to order.

Selectman Darcy made a motion to accept the minutes of March 5, 2012, Selectmen Schill second. Motion passes, Chairmen Smith and Selectmen Rideout abstained.
