- Community Center Report, Program Updates: Theresa read aloud Sarah's attached report to the committee.
- Update of Summer Camp as reported by Kleay Steever: Counselor trainings are scheduled for next week. Ann is coordinating with Kleay for payroll training for the employees. Campers are still signing up.
- Pool Update as reported by Theresa Diorio: Tim Kerylow will be offered a contract by the town Selectboard. Jack White has been instrumental in helping to facilitate this, in addition to Sarah Hudon and Kathryn Lynch. Theresa is working toward allowing pool guests under the current minimum age of 13 to come without a parent (with signed consent). No one is presently certified to provide swimming lessons. Theresa is working toward offering a class that can be provided within safety guidelines/protocol with the pool staff currently in place. Town employees will do the chemical treatment for the pool this season, and Tim Kerylow is slated to perform other maintenance (pending contract acceptance). The town pool was recently power washed but was not painted as the weather conditions (and forecasts) were not conducive to this. The pool's anticipated opening will occur after AED units are replaced or updated (such as pad replacements) as needed. Theresa reported that she is hoping for a soft opening

next week, excluding the following weekend due to unavailability of lifeguard staff that weekend. Theresa consulted the Committee regarding scheduling. Discussion followed; likely official opening July 5. The pool will be open to the public during summer camp hours as per previous seasons.

- Lifeguard staff: seems to be adequate at the moment. Some final hiring details are in the works.
